SUBJECT

Maintenance of the codes

DIGEST

This is the annual maintenance of the codes bill.

PROPOSED CHANGES TO THE LAW

There are no changes to existing law. This measure is nonsubstantive.

COMMENTS

1. Commitment to delete any substantive provision

A condition for inclusion in the annual code maintenance bill is that the change must be nonsubstantive. Consequently, any provision that is identified as making a substantive change will be deleted by the Office of Legislative Counsel.

2. “All-purpose” yielding clause avoids double jointing problems

Proposed Section 169 on page 446 of this bill includes an “all purpose” yielding clause that avoids any double jointing problems that might otherwise occur.

3. Amendment

Section 28 of this bill was added on March 16, 2022. AB 2179 (Grayson, Ch. 13, Stats. 2022) was chaptered on March 31, 2022 with an urgency clause. The enactment of the urgency measure makes section 28 substantive. Therefore, section 28 must be removed from the bill.

Amendment 1:

Remove Section 28.
